AND WHEREAS I hope that the said interests and objects can be attained by devoting the undermentioned Trust-Amount and its income;

NOW THIS DEED Witnesseth, and I do hereby declare as follows:-

I. NAME OF TRUST: The name of Trust shall be IRSHADIYA CHARITABLE TRUST, PAREEKANNI. P.O. The short name of 'IRSHADIYA TRUST' may be used in all its transactions.

II. OFFICE: The Head Office of the Trust shall be situated at Pareekanni. But it can be shifted to any other place in Kerala. Sub-offices may be opened at other places if the





- D. To help and assist in all possible manners those people living below the poverty line irrespective of Caste, Religion or community and to do all things to improve their standard of living in all walks of life.
- E. To promote and foster religious harmony between all religious communities in India and to co-operate with

- H. To establish and conduct non-interest Banks to promote the economic balance of the Society.
- I. To create and establish Craft and Industrial Training Centres, Industries and business concerns with a view to provide work to solve unemployment.
- J. And to do all such other acts, deeds, and things to help, assist to all social and national institutions as the Board decides.





V. POWERS OF THE BOARD:

- A. The Board shall appoint the necessary staff, employees and other officials for the functioning of the Trust and shall have power to decide all matters relating to such appointments and other relevant factors in connection with the same.
- B. The Board shall approve an annual budget for ensuing financial year categorising the heads of income and expenditure. But the Board is at liberty to expand the unspent amount for one category to the other according to importance, urgency and circumstances. The financial year shall be January to December.
- C. The Board shall have power to accept the trusteeship, Mutavalliships or the managements of another trusts, Wakafs or endowments and such Trusts, Wakafs, or endowments shall be administered under the provisions of this deed in addition to any other agreeable directions made by the donor of such trusts, Wakafs, or endowments.
- D. The Board shall have powers to acquire, accept or receive all endowments, gifts, grants, donations and any other contributions of any sort, movable or immovable made to this Trust, by individuals, groups, families, organisations, or association whether incorporated or not, or by any government, State, Central or Foreign and all such Gifts, Grants, donations and contributions would be considered as part of this trust properties and their managements, income and expenditure shall be unconditionally carried on as per provisions of this deed.
- E. The Board shall have the power to sell the movable and immovable properties of this Trust or any part thereof in case of unavoidable necessity and circumstances or for purchasing other more beneficial properties. The Board also shall have the power to Pawn, pledge or mortgage the Trust properties

IX FUNCTIONS THE CHAIRMAN:

The Chairman will preside over the Board Meetings supervise the functioning of the Board, and give necessary directions to the proper administration of the Board and shall represent the Board in all actions, Civil, Criminal or Revenue and in all Offices of the Government, Central, State and Foreign, including Sales Tax and Incometax Offices, and Offices of the Municipalities or Panchayats and other office and before all appellate authorities of such offices, unless and until decided otherwise by the Board. The Chairman is also empowered to delegate his powers to another trustee or trustees or other persons to get things done as his representative for specific purposes.

X. CASTING VOTE AND VETO POWER:

When the Board in session is equally divided in voting, the Chairman will have the right of casting. Besides the Casting vote, the Chairman will have the Veto ~~Power~~ power, the right of which can be exercised on such occasions as he deems necessary. This right of casting and vetoing shall not be exercisable by other persons who happen to be the presiding personals of the Board.

XI. MANAGING TRUSTEE:

In view of the convenient management of the Trust, a Managing Trustee may be appointed either salaried or honorary if the Board deems it fit and necessary from one among them for three years. The Managing Trustee so appointed shall perform the day-to-day administrations and management of the Trust including the preparation of the annual budget. He must be in charge of keeping the books of accounts and writing the receipts and expenditure of the Trust and shall convene the meetings of the Board according to the instruction of the Chairman. The Managing Trustee shall not keep in hand an amount more than Rs.5,000/-. The Managing Trustee is also entitled to such allowances, data or grant as decided by the Board.

XII. MEETINGS AND SITTING ALLOWANCES:

Ordinary meetings of the Board may be convened as and when found necessary by issuing three days notices to the members of the Board. The attending members are eligible to get sitting allowances, bata and travelling expenses in such manners and from such period as and when decided by the Board. The Managing Trustee may submit before the Board in every sitting the working report of the Trust.

XIII. QUORUM AND MAJORITY:

The Quorum of the Board shall be three in number and all the decisions of the Board shall be in writing and the majority of the members present. The majority decision of the Board shall not be questioned by any member of the Board. But the Board will have its discretion to review its own decisions. If any meeting is adjourned for want of quorum and if \neq convened within one month, decisions may be validly passed without required quorum.

XIV. DISCIPLINARY ACTION:

Any trustee or Trustees whose behaviour are found detrimental to the interest of the Trust may be proceeded against by suspension and dismissal by a resolution approved by the Board by majority votes.

XV. BYE-LAWS:

To facilitate the smooth administration of this Trust, the Board by two third majority frame bye-laws which shall not be repugnant to any article of this deed or against the objects and purpose of this Trust.

XVI. AUDITING:

The accounts of the Board will be audited by Chartered Accountants or other auditors including the Board members appointed by the Board.

XVII. IRREVOCABILITY:

This Trust is an irrevocable Trust and neither I nor my descendants, nor legal heirs have any right or authority to revoke it. But it can be joined or amalgamated with other Trusts having

the same objects with a resolution passed by the Board with two third majority decision of the Board members.

XVIII. TRANSFER OF THE TRUST AMOUNT:

I have today handed over on this 23rd day of September 1991, the sum of Rupees One thousand to the Trustees of this board towards the Trust amount of this Trust which they acknowledge and agree to hold in trust with and subject to the powers, provisions and declarations contained in this Trust Deed.

XIX. ACT APPLICABLE:

This Trust is to be governed by the provisions of Indian Trust Act (Act 11 of 1982)

XX. VALUATION:

This Trust is valued at Rs.1,000/- this amount being donated by the above said K.M.Syed Muhammed Maulavi.
